CALL TO ORDER

Chairman Sam Newby called the meeting to order at 10:01 a.m. Mike Cole led the Invocation and the Pledge of Allegiance.

PUBLIC COMMENT

None at this time.

CONSENT AGENDA

▶1. NORTH FLORIDA TPO MINUTES OF JUNE 10, 2021

LeAnna Cumber moved to approve the Consent Agenda; Elaine Brown seconded; motion unanimously carried.

AGENDA

► A. FINANCE COMMITTEE REPORT

Representing the Finance Committee, Angela Session reported that the May financials have been accepted.

►B. FDOT REQUESTS AMENDING THE TRANSPORTATION IMPROVEMENT PROGRAM (TIP) FOR FY 2021/22 THROUGH FY 2025/26 TO INCLUDE PROJECTS IN THE ROLL FORWARD REPORT

Autumn Martinage presented the amendment to the Transportation Improvement Program for FY 2020/21 through FY 2025/26.

The Roll Forward Amendment includes projects or phases of projects that were approved in the FY 2021/22 through FY 2025/26 TIP, but were authorized or begun prior to July 1, 2021. These projects then "Roll Forward" into the first year of the new FY 2021/22 through FY 2025/26 TIP.

Ms. Martinage asked for questions. There are no questions at this time.

Elaine Brown moved to approve the FDOT's request to amend the Transportation Improvement Program (TIP) for FY 2021/22 through FY 2025/26 to include projects in the "Roll Forward" report; Randi DeFoor seconded; motion unanimously carried.

C. <u>AMENDMENT OF THE UNIFIED PLANNING WORK PROGRAM</u> (UPWP) FOR FY 2020/21 THROUGH FY 2021/22 (ENCUMBERING FY 2019/20 FUNDS)

Angela Session presented the amendment of the Unified Planning Work Program (UPWP) for FY 2020/21 through FY 2021/22 to encumber FY 2019/20 PL funds.

At the end of the prior year's UPWP (FY 2018/19 through FY 2019/20), there was a contract balance \$198,005 (PL funds). FDOT now advises that these funds may be encumbered into this year's UPWP (FY 2021/22). These funds will be programmed to Task 1.5 General Consultant Services to be used to support additional work task orders or contingencies for current studies.

Ms. Session asked for questions. There are no questions at this time.

Daniel Bean moved to approve the amendment of the Unified Planning Work Program (UPWP) for FY 2020/21 through FY 2021/22 to encumber FY 2019/20 PL funds; LeAnna Cumber seconded; motion unanimously carried.

D. AMENDMENT OF THE METROPOLITAN PLANNING ORGANIZATION AGREEMENT (INCREASING BUDGETARY CEILING BY \$371,747 - REMAINING BALANCE FROM CLOSE OUT OF FY 2018/19 THROUGH FY 2019/20 UPWP)

Angela Session presented the amendment of the Metropolitan Planning Organization Agreement to increase the budgetary ceiling.

At the end of the prior year's Unified Planning Work Program (UPWP) (FY 2018/19 through FY 2019/20), there was a total contract balance of \$371,747. An amendment was approved in March 2021 to encumber the remaining SU and CMAQ funds from FY 2019/20 for \$142,625 and \$31,117 respectively.

This amendment is to encumber the remaining \$198,005 of PL funds from FY 2019/20. The previous UPWP amendment and this proposed amendment will

increase the ceiling of the Metropolitan Planning Agreement, thus creating the need for a contract amendment.

Ms. Session asked for questions.

Randi DeFoor asked why there was an increase of \$371,747.

Ms. Session responded that in March these were remaining UPWP funds from the previous year's SU and CMAQ. The UPWP amendment to encumber those remaining funds was approved by the Board in March 2021. Staff was waiting for the PL funds to become available.

Daniel Bean moved to approve the amendment of the Metropolitan Planning Organization Agreement to increase the budgetary ceiling by \$371,747; Randi DeFoor seconded; motion unanimously carried.

E. <u>DRAFT PROJECT RECOMMENDATIONS FOR SU FUNDING FOR</u> FY 2022/23 THROUGH FY 2026/27

Jim Knight of FDOT presented the draft project recommendations for SU funding for FY 2022/23 through FY 2026/27.

Staff will present this item in September for final review and action.

Mr. Knight asked for questions.

- Randi DeFoor asked if the COJ funds for the Max Leggett Parkway are coming from JIA/CRA.
 - Mr. Knight responded that is correct.
- Randy White wanted to know if Normandy Blvd. is still on the list.
 - Mr. Knight responded that Normandy Blvd. is high on the LOPP.
- Randy White commented that COJ is already going to four-lane Chaffee Road from I-10 to Normandy, as well as upgrade the existing roadway between Old Plank Road and Beaver Street. This will tie into FDOT's project. Mr. White wanted to know if FDOT will communicate with COJ if their portion of the project can be done earlier.

Mr. Knight commented that there is a need to coordinate with COJ because FDOT is acquiring right-of-way and it is inadequate for a four-lane road. There will also be upgrades for all four approaches of that intersection along with bike and pedestrian improvements.

F. DRAFT PROJECT RECOMMENDATIONS FOR CMAQ FUNDING FOR FY 2022/23 THROUGH FY 2026/27

Jim Knight of FDOT presented the draft project recommendations for CMAQ funding for FY 2022/23 through FY 2026/27.

Staff will present this item in September for final review and action.

Mr. Knight asked for questions.

- LeAnna Cumber thanked Mr. Knight for his help on the Hendricks Avenue San Marco interchange.
- Randi DeFoor asked if St. Johns Avenue is the roundabout project.
 - Mr. Knight responded that is correct.
- Randi DeFoor commented that it does not look like any money is being expended this year on that project.
 - Mr. Knight responded that FDOT expended funds in previous years through the design effort. This project is on track for construction.
- Ray Alfred wanted to know if the roundabouts are done as a result of a request from the community or the result of a traffic study.
 - Mr. Knight responded that it initiated as a request from the community; however, the traffic study confirmed that it would be a good improvement.
- Randy White wanted to know the timeline for completion of the intersection improvements on I-10 west.
 - Mr. Knight responded that those improvements are part of the I-10 widening and the interchange work at I-295 should be complete within a few months. The remaining work should be finished within three to five years.

G. SMART NORTH FLORIDA UPDATE

Clayton Levins gave the following update.

- Several start-ups have partnered with the surrounding counties to deploy their technology in the form of a pilot project.
 - Robotics is using data analytics and artificial intelligence to assess pavement management conditions in St. Augustine.

Ubicquia is working on a smart lighting project in Keystone Heights.
 They are also using vertical assets to give access to public Wi-Fi within the Jacksonville area.

Gordon Folkes, founder and CEO of Archer First Response, gave a brief presentation on his unmanned air systems (UAS).

Mr. Folkes asked for questions.

- Daniel Bean wanted to know if the equipment comes with instructions.
 - Mr. Folkes responded that the 911 Operator would walk the person through step-by-step how to operate the various equipment. The defibrillator has verbal prompts to walk a person through the process.
- Daniel Bean wanted to know if this program is operational in Manatee County.
 - Mr. Folkes responded that this program has been operational for over a year and a half in Manatee County.
- Daniel Bean wanted to know if Mr. Folkes has negotiated with the insurance carriers to cover costs.
 - Mr. Folkes responded that his company leases the infrastructure and equipment to the counties and municipalities. A county cannot drive a huge revenue but can charge to recoup operational costs.
- Ray Alfred wanted to know about any coordination between JFRD and JSO.
 - Mr. Folkes responded that we are not currently working in the Jacksonville area.
- Daniel Bean asked about the coordination between the fire department and the sheriff's office in Manatee County.
 - Mr. Folkes responded that this software is integrated into the 911 dispatch system. The 911 Operator determines if the situation would be better served by a drone or an ambulance for a cardiac arrest or opioid overdose and dispatches the appropriate entity.

The drone hovers at 200 feet and does not land. It is equipped with a parachute recovery system and needs to maintain a minimum deployable altitude.

- Ray Alfred encouraged Mr. Folkes to coordinate with the county and/or community where this program is deployed for civilian training of the equipment and how to perform CPR.
 - Mr. Folkes responded that the coordination comes down to the 911 Operator and the caller.
- Mayor Elaine Brown commented that the training would be very beneficial especially in a stressful situation as this.
- Christian Whitehurst wanted to know the cost to cover St. Johns County.
 - Mr. Folkes responded that we do 12, 24 or 36-month leases for the infrastructure. Each system covers 35 square miles. When we work with an agency, we get the cardiac and opioid data and plot it on a map. Then, we look at where the concentration is for these instances. This helps us to determine what areas to cover. For example, divide the amount of miles in St. Johns County by 35. It is \$3500 per month per system for a 36-month lease with 175 miles of coverage.
- Randi DeFoor commented that the value of this product seems better suited for a rural area versus a concentrated area.
 - Mr. Folkes responded that is somewhat correct. The suburban areas have more instances of cardiac arrest versus instances in a rural area. We are quick and very effective in both areas.
- Ray Alfred encouraged Mr. Folkes to work with the Red Cross and the American Heart Association to get the communities educated.

H. EXECUTIVE DIRECTOR'S REPORT

I. SECRETARY OF TRANSPORTATION'S REPORT

J. AUTHORITY REPORTS

Ray Alfred – Jacksonville Aviation Authority – On July 27 we decommissioned the air traffic control center. The new air traffic control center is located at Cecil Field.

Daniel Bean – JAXPORT – Harbor deepening is ahead of schedule and should be complete by the end of 2022. Cargo volumes remain steady and strong. The cruise lines are still on hold until the end of October. The Governor awarded JaxPort \$13 million as a port that operates a cruise line as their main or only source of revenue to be used for capital improvements.

Mike Cole – Nassau County Ocean Highway and Port Authority – Tonnage is stable. Awaiting COVID relief funding for \$800,000.

Greer Gillis (on behalf of Ari Jolly) – Jacksonville Transportation Authority JTA's Gameday Xpress, which is a shuttle service that provides a direct connection from five JTA parking locations to TIAA Bank Field for all Jacksonville Jaguars home games, is back for the 2021 NFL season starting with the August 14th preseason game against the Cleveland Browns. Service begins two hours before kick-off and continues for one hour after each game ends. New for the 2021 NFL Season, the JTA is introducing mobile cashless ticketing to promote a safer, more efficient Gameday Xpress experience. Customers can purchase secure mobile tickets through either the MyJTA app or the Token Transit app. Season passes are just \$50 and include roundtrip service for all Jaguars home games. Single game passes are \$8 from downtown locations and \$13 from suburban locations.

The JTA has partnered with Uber to provide free door-to-door rides to and from COVID-19 vaccination sites in neighborhoods with limited transportation access. The program is part of the JTA's Ride to Health Initiative which provides safe, clean and reliable transportation to available COVID-19 vaccination distribution locations. Uber is subsidizing 100 percent of the cost for approximately 4,000 rides. Vouchers, which require the Uber app to be claimed, are available for trips to any vaccination site within the combined area of 10 zip codes listed on our website. The program will run through Thursday, September 30, 2021. Trips can be scheduled Monday through Sunday between 7 a.m. and 6 p.m. at no cost to the customer for trips under \$25.

Over the summer, the JTA launched a Reduced Fare Pilot Program that expanded our reduced fare eligibility to include anyone receiving benefits through Temporary Assistance for Needy Families (TANF), Women, Infants and Children (WIC), or the Supplemental Nutrition Assistance Program (SNAP), along with those who qualify for Section 8 housing. This new eligibility criteria builds upon our existing fare structure that provides reduced fares for customers who have a qualifying disability, including veterans with disabilities; Social Security Disability (SSD), Supplemental Security Income (SSI) and Medicare recipients. Qualified customers have the option to purchase a reduced fare pass through the Token Transit mobile app or a reduced fare STAR Card at one of our ticket centers. The Reduced Fare Pilot Program runs through September 30, 2021, and eligible customers who sign up for the program prior to the September 30th deadline can purchase reduced fare passes for an entire year.

In an industry first, Goodyear has developed an airless tire and wheel assembly to support autonomous vehicle (AV) transportation in a city setting for in-field use in JTA's AV Test & Learn Program. For the past three years, Goodyear in partnership with Local Motors has tested an Olli shuttle supported by the airless tire at Goodyear testing facilities and other locations reaching several performance targets. The airless tires will be tested on JTA's Olli 2.0 AV shuttle which is a 3D-printed vehicle

developed by Beep, Local Motors by LM Industries, and Robotic Research LLC that JTA began using in its Test & Learn program last year.

The North Florida TPO was notified that the final allocation of Federal Transit Administration 5305(d) funds for Fiscal Year 2021/22 is \$38,811 less than the amount that was programmed in the May 2020 adoption of the Unified Planning Work Program. The final allocation was unknown at the time of budgeting. Now that the final allocation has been received, the UPWP must be amended to reflect that amount. Resolution 2021-6 is being submitted for approval, authorizing a Joint Participation Agreement in the amount of \$657,808.

This amendment is to also replace the 10% Local and 10% State hard match with a 20% soft match using toll credits at the direction of the Florida Department of Transportation.
