Autumn Martinage presented the amendment to the Transportation Improvement Program for FY 2020/21 through FY 2024/25.

Ed Lehman moved to approve the FDOT's request to amend the Transportation Improvement Program (TIP) for FY 2020/21 through FY 2024/25; Sean Lynch seconded; motion unanimously carried.

► C. <u>DRAFT JOINT CERTIFICATION OF THE METROPOLITAN</u> TRANSPORTATION PLANNING PROCESS

Denise Bunnewith presented the annual draft Joint Certification of the Metropolitan Transportation Planning Process that is conducted with FDOT. Approval will be requested at the March meeting.

Ms. Bunnewith asked for questions.

• Autumn Martinage commented that the TPO is considered low-risk and does a great job in meeting the requirements.

D. DRAFT 2021 LIST OF PRIORITY PROJECTS

Denise Bunnewith presented the draft 2021 List of Priority Projects. Approval will be requested at the March meeting.

Ms. Bunnewith asked for questions.

- Ed Lehman requested that the project limits for SR 21 Blanding Boulevard be changed to CR 220 to Collins Road.
- Chairman Franklin wanted to know if there is a deadline for comments.

Ms. Bunnewith responded that it would be great if we could get comments before the March 11 TPO Board meeting.

- Jeff Sheffield informed the group that if we do not receive anything from the independent authorities they will be removed from the list.
- Scott Kornegay informed the group that this past summer an accessibility study was completed for the Keystone Heights Airport. One item addressed in the study was Airport Road, which is the only entrance into the airport. The consultant put forth four scenarios to address the situation. The first three are maintenance projects, with the fourth being a capacity project. The Keystone Heights City Council approved moving forward with the capacity project. This will be presented to the Clay County Board of Commissioners next week, and we anticipate this being ready to be added to the LOPP.

• Ed Lehman asked to change the projects limits for the CR 220 project on the TRIP list to SR 21 to Henley Road.

E. <u>FDOT TENTATIVE WORK PROGRAM FOR FY 2021/22 THROUGH</u> <u>FY 2025/26</u>

Autumn Martinage presented the FDOT Tentative Work Program for FY 2021/22 through FY 2025/26.

Ms. Martinage asked for questions.

• Laurie Santana wanted to know if this list is the same as the FDOT's Five-Year Citizen Plan.

Ms. Martinage responded that it is based on the January 21 version of the Citizens Plan that is located on the District 2 Work Program website. These projects are in the tentative five-year work program and will be in the adopted TIP in June.

 Laurie Santana commented that the document she downloaded was for FY 2021 – FY 2026. Ms. Santana asked Ms. Martinage to send her the FY 2020/21 – FY 2024/25 version of the TIP.

Ms. Martinage responded that is the current adopted TIP, which is the same as the work program and is located on the TPO's website.

F. JAXPORT PRESENTATION

Robert Peek of JAXPORT gave a brief overview of the Port and the pandemic's economic impact on their day-to-day operations.

Mr. Peek asked for questions. There were no questions at this time.

G. <u>SMART NORTH FLORIDA UPDATE</u>

Jeff Sheffield gave the following update.

• SNF has begun to pursue opportunities outside the realm of transportation. We have applied for a National Science Foundation Grant to deploy broadband in the east side of Jacksonville. This is demographically one of the most challenged communities in northeast Florida. An award announcement is anticipated the end of February.

This application allowed us to build partnerships with JEA, COJ, Lift Jax, Miller Electric as a provider for a private LTE network, and Duval County Schools as they manage 10,000 hotspots and 100,000 laptops for students. We pulled metrics for students in that neighborhood that are using these laptops and losing connectivity. Through that private LTE network, we will have the ability to swap out their dongles so they will be using this particular network.

 SNF was included in a HOPE grant submittal by the Northeast Florida Regional Council in partnership with Putman County for micro transit to connect the underserved in Putnam County's rural areas to jobs and healthcare.

The Northeast Regional Council is now burdened with the idea of leveraging SNF to connect creators to develop an idea to better connect Putnam County underserved residents to jobs and healthcare through micro transit. This will lead to developing an app to connect people to the various mobility services that are available.

- FDOT was successful in securing a \$1 million state grant in partnership with St. Augustine to continue their efforts in deploying Smart City elements throughout the city.
- We are working to set up a RoadBotics demonstration to show the additional platform that comes with the pavement assessment component of their pavement management system.
- We are continuing conversations with TechStars, an international entrepreneurial accelerator. They have proposed a turn-key accelerator that over a three-year period would do cohort meetings three times a year in transportation, healthcare or finance. It would bring startups into our community for a 90-day boot camp to grow their businesses in the space that we brand. There is also an interim process called a Community Catalyst. This is a cost effective first step that would engage TechStars for 12 months with a locally hired face to it that would bring their resources in. Based on their international expertise in the space, they would evaluate our ecosystems to set the roadmap of how to get there and/or validate where we might need to fill in gaps before we could pull off that effort.

Chris LeDew wanted to know the name of the company that does the inventory.

Mr. Sheffield responded that it is RoadBotics a startup out of Pittsburg, Pennsylvania.

Chairman Franklin announced that St. Johns County Property Appraiser's Office hired CycloMedia to provide street level imagery of all business and residential areas within the county.

As they have this inventory, they have asked the City of St. Augustine if we are interested in the data.

H. OLD BUSINESS

None at this time.

G. NEW BUSINESS

• Suraya Teeple announced that JTA is coordinating with COJ and the local hospitals to provide access to vaccine sites throughout Duval County.

Ms. Teeple congratulated the Northeast Florida Regional Council on being awarded the HOPE grant. This was a collaborative effort between the Northeast Florida Regional Council and the Regional Transit Working Group.

JTA received a CTD grant to partner with Patriot Transportation Services Group to offer transportation to homeless veterans.

- Beth Payne announced that the Northeast Florida Regional Council in partnership with the Department of Economic Opportunity is hosting a virtual broadband planning strategic workshop Thursday at 2:30 p.m.
- Sean Lynch announced that Senate Bill 62 is to take the mandatory requirement away from counties to be part of the Regional Council. There are ten regional councils within the State of Florida. If the requirement goes away, the regional councils would lose a significant amount of funding.

- DATE: March 11, 2021

At the end of the prior year's UPWP (FY 2018/19 - FY 2019/20), there was a contract balance in the amounts of \$142,625 (SU funds) and \$31,135 (CMAQ funds). FDOT now advises that these funds may be encumbered into this year's UPWP (FY 2020/21). These funds will be programmed to Task 1.5 General Consultant Services to be used to support additional work task orders or contingencies for current studies.

Staff proposes amending the revised Unified Planning Work Program for Fiscal Years 2020/21 through 2021/22. The attached table summarizes the proposal.

Purpose

Each year, the District and the Metropolitan Planning Organization (MPO) must jointly certify the metropolitan transportation planning process as described in <u>23 C.F.R. §450.336</u>. The joint certification begins in January. This allows time to incorporate recommended changes into the Draft Unified Planning Work Program (UPWP). The District and the MPO create a joint certification package that includes a summary of noteworthy achievements by the MPO and, if applicable, a list of any recommendations and/or corrective actions.

The Certification Package and statement must be submitted to Central Office, Office of Policy Planning (OPP) no later than June 1.



Certification Process

Please read and answer each question within this document.

Since all of Florida's MPOs adopt a new Transportation Improvement Program (TIP) annually, many of the questions related to the TIP adoption process have been removed from this certification, as these questions have been addressed during review of the draft TIP and after adoption of the final TIP.

As with the TIP, many of the questions related to the Unified Planning Work Program (UPWP) and Long-Range Transportation Plan (LRTP) have been removed from this certification document, as these questions are included in the process of reviewing and adopting the UPWP and LRTP.

Note: This certification has been designed as an entirely electronic document and includes interactive form fields. Part 2 Section 9: Attachments allows you to embed any attachments to the certification, including the <u>MPO Joint Certification Statement</u> document that must accompany the completed certification report. Once all the appropriate parties sign the MPO Joint Certification Statement, scan it and attach it to the completed certification in Part 2 Section 9: Attachments.

Please note that the District shall report the identification of and provide status updates of any corrective action or other issues identified during certification directly to the MPO Board. Once the MPO has resolved the corrective action or issue to the satisfaction of the District, the District shall report the resolution of the corrective action or issue to the MPO Board.

The final Certification Package should include Part 1, Part 2, and any required attachments and be transmitted to Central Office no later than June 1 of each year.



Risk Assessment Process

Part 2 Section 1: Risk Assessment evaluates the requirements described in <u>2 CFR §200.331 (b)-(e)</u>, also expressed below. It is important to note that FDOT is the recipient and the MPOs are the subrecipient, meaning that FDOT, as the recipient of Federal-aid funds for the State, is responsible for ensuring that Federal-aid funds are expended in accordance with applicable laws and regulations.

(b) Evaluate each subrecipient's risk of noncompliance with Federal statutes, regulations, and the terms and conditions of the subaward for purposes of determining the appropriate subrecipient monitoring described in paragraphs (d) and (e) of this section, which may include consideration of such factors as:

(1) The subrecipient's prior experience with the same or similar subawards;

(2) The results of previous audits including whether the subrecipient receives a Single Audit in accordance with Subpart F—Audit Requirements of this part, and the extent to which the same or similar subaward has been audited as a major program;

(3) Whether the subrecipient has new personnel or new or substantially changed systems; and

(4) The extent and results of Federal awarding agency monitoring (e.g., if the subrecipient also receives Federal awards directly from a Federal awarding agency).

(c) Consider imposing specific subaward conditions upon a subrecipient if appropriate as described in §200.207 Specific conditions.

(d) Monitor the activities of the subrecipient as necessary to ensure that the subaward is used for authorized purposes, in compliance with Federal statutes, regulations, and the terms and conditions of the subaward; and that subaward performance goals are achieved. Pass-through entity monitoring of the subrecipient must include:

(1) Reviewing financial and performance reports required by the pass-through entity.

(2) Following-up and ensuring that the subrecipient takes timely and appropriate action on all deficiencies pertaining to the Federal award provided to the subrecipient from the pass-through entity detected through audits, on-site reviews, and other means.



(3) Issuing a management decision for audit findings pertaining to the Federal award provided to the subrecipient from the pass-through entity as required by §200.521 Management decision.

(e) Depending upon the pass-through entity's assessment of risk posed by the subrecipient (as described in paragraph (b) of this section), the following monitoring tools may be useful for the pass-through entity to ensure proper accountability and compliance with program requirements and achievement of performance goals:

(1) Providing subrecipients with training and technical assistance on program-related matters; and

(2) Performing on-site reviews of the subrecipient's program operations;

(3) Arranging for agreed-upon-procedures engagements as described in §200.425 Audit services.

If an MPO receives a Management Decision as a result of the Single Audit, the MPO may be assigned the high-risk level.

After coordination with the Office of Policy Planning, any of the considerations in 2 CFR §200.331 (b) may result in an MPO being assigned the high-risk level.

The questions in Part 2 Section 1: Risk Assessment are quantified and scored to assign a level of risk for each MPO, which will be updated annually during the joint certification process. The results of the Risk Assessment determine the minimum frequency by which the MPO's supporting documentation for their invoices is reviewed by FDOT MPO Liaisons for the upcoming year. The frequency of review is based on the level of risk in **Table 1**.

FDOT Joint Certification Part 2 – FDOT District




Figure 1. Risk Assessment: Certification Year vs. Monitoring

The Risk Assessment that is part of this joint certification has two main components – the Certification phase and the Monitoring phase – and involves regular reviewing, checking, and surveillance. The first step is to complete this Risk Assessment during the joint certification for the current year (*The red line in Figure 1*). The current year runs for a 12-month period from January 1 to December 31 of the same year (*Example: January 1, 2018 through December 31, 2018*). There is a 6-month period when the joint certification for the current year is reviewed before the Risk Assessment enters the Monitoring phase. The joint certification review runs from January 1 to June 30 (*Example: January 1, 2019 through June 30, 2019*). After the review has been completed, the Risk Assessment enters the Monitoring phase, where the MPO is monitored for a 12-month period (*Example: July 1, 2019 to June 30, 2020*). The entire Risk Assessment runs for a total of 30-months. However, there will always be an overlapping of previous year, current year, and future year Risk Assessments. **Figure 1** shows the timeline of Risk Assessment phases and how Risk Assessments can overlap from year to year.

OVERVIEW

The North Florida Transportation Planning Organization (North Florida TPO) Transportation Improvement Program (TIP) for Fiscal Years 2022/2023 through 2026/2027 begins with preparing a "*List of Priority Projects*" to be used in developing the Florida Department of Transportation's (FDOT) Tentative Five Year Work Program. The "*List of Priority Projects*" identifies potential projects to be funded in the new fifth year (2026/2027) of the FDOT Work Program. However, by creating the Strategic Intermodal System (SIS) and the Transportation Regional Incentive Program (TRIP) in Florida, the "*List of Priority Projects*" now includes potential projects to be funded in other years of the FDOT Work Program under the SIS and TRIP programs. The "*List of Priority Projects*" includes a prioritized listing of state highway, mass transit, aviation, intermodal, and Transportation Alternative Program (TAP) and Transportation Regional Incentive Program (TRIP) to Program (TRIP) projects and was approved by the North Florida TPO Board March 11, 2021¹.

The North Florida TPO expects all projects currently programmed in the FDOT Work Program to advance to the next development phase. This will ensure that implementing the 3-C planning process (continuing, cooperative, and comprehensive) in the North Florida TPO area is being implemented, as required by federal and state statutes. If FDOT cannot complete the programmed phase and advance the project to the next logical phase, it is incumbent that the agency provides an explanation to the North Florida TPO.



DRAFT Requested Studies for FY 2021/22 Unified Planning Work Program (UPWP)

A1A Ocean Islands Trail Scenic Byway Sustainability Study

The scenic byway has the potential to be both an economic and tourism generator. This study will explore ways for the byway to achieve local, regional and state economic development and tourism goals.

Amelia Island to Jacksonville Commuter Study

Riverplace at Summer Beach Property Owners Association

To study of commuter traffic generated by Nassau County residents commuting to and from Jacksonville via First Coast Highway and Heckscher Drive (SR A1A).

CR 305 Extension Feasibility Study St. Johns County

This study will explore the feasibility and need for extending CR 305 from SR 206 to CR 13S/CR204 as a new N/S corridor and extension of CR 2209. The study will determine if the project is feasible and when it will be needed.

East Coast Greenway Feasibility Study (Task 5.10) Atlantic, Neptune and Jacksonville Beach

To determine the feasibility of constructing a paved recreational trail parallel to the beach through Atlantic, Neptune and Jacksonville Beaches.

First Coast Expressway Impact Study St. Johns County

This study will utilize the NERPM-AB to analyze the impact of the First Coast Expressway at buildout in 2030 on the local road network (collector and above) in St. Johns County.
