CALL TO ORDER

Chairman Stack called the meeting to order at 2:02 p.m. and Jim Hill led the Pledge of Allegiance.

PUBLIC COMMENT

None.

Jeff Sheffield made the following comments.

- Due to the recent changes to the bylaws, members are no longer "at-large". Certain seats are no longer specific to an organization. Each member will represent the county.
- Please direct all communication to Jennifer Lott as opposed to individual staff. This will ensure that all questions/comments are addressed in a timely manner.
- To keep the meetings more organized and give everyone a chance to speak, please do not speak unless recognized by the Chair.

Jeff Sheffield presented the TPO's "Work Product" timeline and gave a brief update.

► A. <u>APPROVE THE APRIL 6, 2022 MEETING MINUTES</u>

Chairman Stack asked for approval of the minutes of the April Citizens Advisory Committee meeting.

Charles Pappas moved to approve the April 6, 2022 minutes; Tyrona Clark-Murray seconded; motion unanimously carried.

► B. FDOT REQUESTS AMENDING THE FY 2021/22 THROUGH FY 2025/26 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)

Mari Schwabacher presented the amendments to the Transportation Improvement Program (TIP) for FY 2021/22 through FY 2025/26.

Ms. Schwabacher asked for questions.

• Tyrona Clark-Murray asked for clarification, as this proposed amendment shows several different road names for SR 115.

Mr. Sheffield responded that from a state perspective, all those roads are SR 115. It can be very confusing as many of the state roads run the entire length of the city.

• Walter Kloss asked if these projects will be added into the current TIP.

Ms. Schwabacher responded that many of these projects will be added into the new TIP. In order for that to happen, they need to be added into the current TIP.

• Walter Kloss asked if this amendment is a result of additional federal funding through the ARPA program.

Ms. Schwabacher responded that some of these projects have ARPA funding and some are a combination of other funding sources.

Mr. Sheffield commented that a lot of this depends on timing. The projects will be in the new TIP, but it does not become effective until October 1. These projects have to be "backed" into the old TIP in order to begin early.

• Michael Wallwork asked that the type of project be included in the request. For example, road widening, intersection improvements, signalization, striping, etc.

Ms. Schwabacher responded that she will do that going forward.

• Austin Chapman asked what type of project is US 17 at Pages Dairy Road.

Ms. Schwabacher responded that the intersection will be modified to address safety concerns. Currently, there is not a complete scope for this project. Ms. Schwabacher will provide the scope once it is available.

• Jim Green pointed out the following error for revision.

447226-1 – SR 115 (Lem Turner Rd.) from 1-95 (SR 9) to SR 111 Edgewood

It should read I-95 instead of 1-95.

Ms. Schwabacher responded that she will correct that.

• Tyrona Clark-Murray asked if SR 5 from State Street to Trout River goes to the river, a road, or the bridge.

Mari Schwabacher responded that this is a resurfacing project from State Street to Trout River.

Mr. Sheffield responded that it will go to the bridge.

Bernie O'Connor moved to approve the FDOT's request to amend the FY 2021/22 through FY 2025/26 Transportation Improvement Program (TIP); Michael Wallwork seconded; motion unanimously carried.

► C. JOINT CERTIFICATION OF THE METROPOLITAN TRANSPORTATION PLANNING PROCESS

Clark Letter presented the annual Joint Certification of the Metropolitan Transportation Planning Process that is conducted with the FDOT.

Mr. Letter asked for questions.

• Jim Green commented that within the TPO portion of the document question #8, page 7 does not have a box checked. Mr. Green asked if the TPO will get "dinged" for not checking a box.

Mr. Letter responded that we will try to correct. This is an electronic form that we are unable to revise.

Mr. Sheffield responded that the TPO will not get "dinged" for not checking the box.

Walter Kloss moved to approve the Joint Certification of the Metropolitan Transportation Planning Process; Bernie O'Connor seconded; motion unanimously carried.

► D. <u>APPROVAL OF THE FY 2022/23 THROUGH FY 2023/24 UNIFIED PLANNING</u> WORK PROGRAM (UPWP)

Clark Letter presented the FY 2022/23 through FY 2023/24 Unified Planning Work Program (UPWP). Since last month, the following changes were made.

• An additional \$299,094 in PL funds has been added to the Consolidated Planning Grant contract. This allowed the permitted funding levels for some work tasks to be increased slightly and following work task to be added.

Task 5.14 – Strategic Safety Plan Update

Mr. Letter asked for questions.

• Jim Green commented that the matrix indicates the changes made; however, the document reads the same as the previous draft.

For example, the matrix indicates that a correction was made within the LRTP task on page 82. The correction is not reflected in the document.

Mr. Letter responded that if anyone notices any changes that were not made please forward them to Jennifer Lott, and we will correct before it goes to the Board.

Jim Green moved to approve the FY 2022/23 through FY 2023/24 Unified Planning Work Program (UPWP); Walter Kloss seconded; motion unanimously carried.

E. <u>STAFF PRESENTATION ON THE DRAFT FY 2022/23 THROUGH FY 2026/27</u> TRANSPORTATION IMPROVEMENT PROGRAM (TIP)

Elizabeth De Jesus presented highlights from the FY 2022/23 through FY 2026/27 Transportation Improvement Program (TIP). The complete draft approval will be requested at the June meeting.

The following projects were deleted from the TIP.

- 4299311 SR A1A from Palmetto Ave. to Sand Castle Lane
- 4260781 SR 13 @ Acosta Bridge & Connector Bridge No. 720570 to Bridge No. 420584
- 4324011 University Blvd. (SR 109) from Los Santos Way to Merrill Road
- 4359521 Cesery Blvd. (SR 109)
- 4380821 Zoo Parkway (SR 105) from I-95 to Main St. ITS Deployment
- 4432981 SR A1A @ Timucuan Trail Crossing and Sawpit Creek Boat Ramp
- 4455761 Dunn Ave. (SR 104) from N. Campus Blvd. to Monaco Dr.

Ms. De Jesus asked for questions.

 Michael Wallwork commented that several trails are in every county except Clay in the TIP. Mr. Wallwork wanted to know how to get the trail he proposed that would run from Orange Park into NAS Jax in the TIP. The City of Jacksonville applied to the TPO last year for funds and were declined.

Mr. Sheffield responded that the City of Jacksonville did not request money for this trail. The only way to apply to the TPO for funds is for the City of Jacksonville to include that project on their list of priority projects.

The TPO's List of Priority Projects is a regional list of 20 projects. Every county submits a list of their priority projects. We will take the first one, two or three projects from each county's list and incorporate them into the regional list.

 Michael Wallwork commented that the project was included on the TPO's list of rejected projects.

Mr. Sheffield responded that the list of rejected studies is from the list of requested studies, and is different from the TIP. No one has applied for funding for this trail nor has a study been completed.

- Mr. Sheffield commented that Clay County Commission is the one that submits the list of priority projects for the area. The TPO will not step in and trump a county's priority list. The project is viable and should be considered; however, Clay County's interest is focused on Cecil and a multi-use trail within that area. That is where the funding has been applied.
- Candice LeCompte wanted to know how to get Clay County Commission's attention.

Mr. Sheffield responded there is no champion for this project and that is what you need. Nassau County had a champion that pushed that trail network and it went forward.

 Mr. Wallwork commented that the C.O. of NAS Jax is not allowed to lobby for this project.

Mr. Sheffield commented that Matt Schellhorn represents the Navy on the TPO Board and does an amazing job, as it relates to interest and projects within the community.

• Lisa McGlynn wanted to know on Anastasia Road if the bike path will be done before the roadwork.

Mr. Sheffield responded that he is not familiar with this project. If the trail is separate from the roadway, then it is not an issue. If it is incorporated into the

roadway, then your concern is valid. We can bring this to the attention of FDOT and the county and let them know your concerns.

• Mr. Sheffield asked the name of the specific road.

Lisa McGlynn responded that the road is Red Cox.

Mr. Sheffield responded that Red Cox is a county project, as it is not a state road.

Lisa McGlynn responded that the road is A-1-A at Red Cox and includes a roundabout.

- Charles Pappas commented that the City of St. Augustine has been working with the state to fix that dangerous intersection. This project is in the preliminary stage.
- Elizabeth De Jesus commented that this project is in the preliminary engineering stage. This is the time to provide your input to FDOT.

Mr. Sheffield commented that this is the point of the presentation. It raises red flags, concerns, etc. and allows us to bring those to FDOT's attention.

• Lisa McGlynn commented that the CAC is being asked to vote on this item June 1, while Clay County's presentation is not until June 7.

Mr. Sheffield responded this is not an action item for the counties. This is just for information.

- Lisa McGlynn commented that she feels the public participation at the county level is the presentation.
- Tyrona Clark-Murray asked about the Dunn Avenue project on the "Deleted Projects" list.

Mr. Sheffield responded that this project has moved into the current year and had to be deleted from next year's list in order to move forward.

We are presenting the TIP beyond our requirement. The virtual meeting is our obligation. There is no action required by the counties. The presentation gives them the ability to offer comment.

 Jim Green commented that the map is wrong on the I-95 from JTB to Atlantic Blvd.

Ms. De Jesus responded that she will correct that.

 Michael Wallwork commented that 9A from I-95 looks like it is going westward. Mr. Wallwork wanted to know where the road will end.

Mr. Sheffield responded that this is 9B. The eventual extension will connect with an interchange because of the First Coast Expressway. It runs through Clay County across the river into St. Johns County near the Shands River Bridge. This is the last piece of that roadway and will close the loop.

F. <u>SMART NORTH FLORIDA UPDATE</u>

Clayton Levins gave the following brief update.

- The City of Neptune Beach will continue their partnership with StormSensors by expanding their deployment of storm sensors within the community.
- In discussions with Advanced Navigation regarding their underwater drone solution for high-resolution imagery and assessment, and with Blue Vigil for a tethered drone to be used by first responders and utility lineman to provide better lighting for them to do their job.
- Emerald Coast MPO is a regional planning council that is home to three MPOs. They came and toured our facility. They are planning to build a TMZ, move into the data space, and start up a smart cities initiative. They want to enter into a consultant agreement with SNF to help them move forward with these initiatives.
