#### **AGENDA**

#### A. FINANCE REPORT

Angela Session reported the May and June financials have been accepted. The audit is underway with all requested materials submitted to the auditor.

# ►B. FOOT REQUESTS AMENDING THE TRANSPORTATION IMPROVEMENT PROGRAM (TIP) FOR FY 2025/26 – FY 2029/30 TO INCLUDE PROJECTS IN THE ROLL FORWARD REPORT

Achaia Brown informed the group the Roll Forward Report includes projects or phases of projects that were approved in the FY 2024/25 – FY 2028/29 TIP but were authorized or begun prior to July 1, 2025. These projects then "Roll Forward" into the first year of the new FY 2025/26 – FY 2029/30 TIP.

Ms. Brown asked for questions. There were no questions at this time.

Solomon Brotman moved to approve the FDOT's request to amend the Transportation Improvement Program (TIP) for FY 2025/26 – FY 2029/30 to include projects in the Roll Forward Report; Nancy Sikes-Kline seconded; motion unanimously carried.

### ►C. AMENDMENT OF THE METROPOLITAN PLANNING ORGANIZATION AGREEMENT

Clark Letter presented the amendment of the Metropolitan Planning Organization Agreement to include PL funds in the amount of \$80,867.

Mr. Letter asked for questions. There were no questions at this time.

Nancy Sikes-Kline moved to approve the amendment of the Metropolitan Planning Organization Agreement; Solomon Brotman seconded; motion unanimously carried.

### ►D. AMENDMENT OF THE UNIFIED PLANNING WORK PROGRAM (UPWP) FOR FY 2024/25 - FY 2025/26

Clark Letter presented the amendment of the Unified Planning Work Program (UPWP) for FY 2024/25 – FY 2025/26.

The UPWP is the task-based budget of the North Florida TPO. It includes administrative tasks, a number of required work tasks such as the TIP, Congestion Management Process, LRTP and other related planning tasks including transit planning, most of which is performed by JTA.

Additional PL funds in the amount of \$80,867 became available and are proposed to be added to "Task 1.5 – General Consultant Services" in year two of the UPWP. To clearly indicate available funds to expend in year two, funds that were not expended in year one of the UPWP are proposed to be moved into year two of the UPWP. This includes CM, PL and SU dollars in the amount of \$64,124.59, \$157,130.50 and \$163,375 respectively for a total of \$384,630.09.

Mr. Letter asked for questions. There were no questions at this time.

Solomon Brotman moved to approve the amendment of the Unified Planning Work Program (UPWP) for FY 2024/25 – FY 2025/26; Klynt Farmer seconded; motion unanimously carried.

### ►E. <u>INNOVATIVE TRUCK PARKING AVAILABILITY SYSTEM (iTPAS)</u> STUDY

Dr. Thobias Sando of UNF presented a brief overview of the study that examined the iTPAS truck parking management system. The study establishes best practices employing camera detection systems in managing truck parking.

Dr. Sando asked for questions.

 Miriam Hill commended UNF, Dr. Sando and his students for the high quality of work on this study.

#### F. SMART NORTH FLORIDA UPDATE

SNF has a pilot underway with each of the following companies.

- Urban Hawk Using computer vision to understand pavement and asset conditions in Green Cove Springs.
- Spot Genius Using computer vision to understand real time parking conditions in St. Augustine for their surface lots and curb parking.
- Geolava Using AI agents and satellite imagery for disaster recovery. This is a result of a problem statement given to us by FDOT District 2.
- Hohonu Understanding flooding conditions with radar and ultrasonic sensors.

Mr. Levins asked for questions. There were no questions at this time.

#### G. <u>EXECUTIVE DIRECTOR'S REPORT</u>

Jeff Sheffield gave the following update.

 The MPOAC has a new executive director and is on a new path going forward.

#### H. <u>SECRETARY OF TRANSPORTATION'S REPORT</u>

Jim Knight informed the Board the First Coast Expressway's last segment will let at the end of this month. It is open to US 17 and under construction from US 17 to CR 2209.

#### I. AUTHORITY REPORTS

**Solomon Brotman – Jacksonville Aviation Authority** – The U.S. Coast Guard has expanded its footprint at Cecil Field. Final design is almost complete for the rebuild of the garage. A sprinkler system will not be included in the rebuild. Concourse B and the new parking garage construction is ongoing. Visitors to our area love our local food vendors at the airport with increased sales last month.

Patricia Gillum Sams – Jacksonville Transportation Authority – On August 21, our CEO, Mr. Ford, had the opportunity to present to the Florida Transportation Commission highlighting our work and successes over this past year and our strategy for moving forward. Also, we welcomed our newest JTA bus operator graduates in late August. This group of 29 talented people committed over 16 weeks to undergo rigorous training and become part of our front-line team. This group of graduates ensures we are fully at our set goal of operator headcount.

On September 8, we implemented our latest round of service enhancements which included the introduction of Red Line Xpress, which provides service from the beaches to downtown, reducing passenger travel time by up to 20 minutes. It will run Monday through Friday with 15-minute frequency during peak morning hours from 6:00 a.m. – 9:00 a.m. and afternoon peak hours from 3:00 p.m. – 6:00 p.m.

On September 4, the JTA was awarded a marketing award by the Florida Public Transportation Association for the Skyway Social event. In addition, Operator Kenneth Kirkland was recognized as the Tier 1 Operator of the Year, and Maintenance Technician Michael Paskanik was recognized as the Tier 1 Technician of the Year. We are so proud of the great work our team does at the JTA.

**James Bennett (for Soo Gilvarry)** – Long-term tariff effects remain uncertain. As of August, we are handling 4% more containerized cargo compared to last year.

Southeast Toyota will begin their transition to Blount Island. The move will take place over a 90-day period, designed to minimize operational disruption. Once complete, Enstructure will assume Southeast Toyota's former acreage at Talleyrand.

Norwegian Cruise Line preparations are underway for the inaugural sailing of the Norwegian Gem on Halloween from Jacksonville. Terminal upgrades include repaving sections of the parking lot to create separate parking areas for Norwegian and Carnival guests. Construction of a new passenger gangway is underway.

Two new container cranes were delivered to Blount Island this summer and are in the final stages of assembly and will be operational in the next month or so. A third crane will be delivered in the coming months and will be operational in 2026. All three cranes were funded by FDOT and manufactured in Ireland.

Miriam Hill – Nassau County Ocean Highway & Port Authority – We are facing many challenges due to the loss of paper and forest business because of mill closures. We have ten-foot tides and have applied for \$11 million in grant funds to stabilize our docks and shore front. Ms. Hill expressed gratitude to the dock workers at the Port of Fernandina.

 Ju'Coby Pittman asked if freight trucks are mandated to have lighting or an audible "beeping" on the back of the truck to indicate they are backing up.

Miriam Hill responded most truck drivers are independent contractors. The responsibility falls with the independent contractor and not the company. They should have lights, sounds and flags to indicate they are backing up.

- Ms. Pittman would like to get one of our representatives to do something on a state level to address this.
- Officer Censon commented trucks are required to have reverse lights on the truck itself and not on the trailer.

**Subject:** Adopting Safety Performance Targets for the North Florida TPO

The Federal Highway Administration (FHWA) published several rules establishing performance measures and reporting requirements for State Departments of Transportation (DOTs) and Metropolitan Planning Organizations (MPOs). These rules establish measures to assess the condition of road safety within MPO boundaries. The defined performance measures that must be tracked by MPOs are shown below:

Performance Measure	Description
Number of Fatalities	The total number of persons suffering fatal injuries in a motor vehicle crash during a calendar year.
Rate of Fatalities	The total number of fatalities per 100 million vehicle miles traveled (VMT) in a calendar year.
Number of Serious Injuries	The total number of persons suffering at least one serious injury in a motor vehicle crash during a calendar year.
Rate of Serious Injuries	The total number of serious injuries per 100 million VMT in a calendar year.
Number of Non-Motorized Fatalities and Non-Motorized Serious Injuries	The combined total number of non-motorized fatalities and non-motorized serious injuries involving a motor vehicle during a calendar year.

FDOT annually establishes statewide safety targets for the following calendar year as part of the HSIP Annual Report, which must be submitted by August 31 each year. Targets are applicable to all public roads regardless of functional classification or ownership.

MPOs have the option of supporting the statewide targets or establishing their own targets for the MPO planning area. MPOs must set their targets within 180 days after FDOT sets the statewide targets. MPOs must annually update their targets by February 27 of each year.



### RESOLUTION 2025-9 ADOPTING SAFETY PERFORMANCE TARGETS

**WHEREAS**, as required by 23 CFR 490, for Calendar Year 2026 the Florida Department of Transportation has adopted aspirational targets for number of *fatalities*, *number of serious injuries*, *fatality rate*, *serious injury rate*, *total number of non-motorized fatalities* and *serious injuries*; and

**WHEREAS**, the North Florida Transportation Planning Organization is also required to adopt annual performance targets for these measures;

**NOW, THEREFORE, BE IT RESOLVED THAT** the North Florida TPO adopts the Florida Department of Transportation performance targets as follows:
